DATA PROTECTION

The new EU General Data Protection Regulations (GDPR) have been updated from the original Data Protetion Act 1998 (DPA). They will apply in the UK from 25th May 2018 and will replace the DPA.

What are the main changes from the DPA to the GDPR? How will they affect clubs like the NNC?

The main changes that affect us are the requirements relating to consent and accountability. The Kennel Club has outlined how Breed Clubs can meet the requirements.

We do NOT use data for marketing purposes and all details of our members are held securely, purely for membership purposes.

However, we need to gain consent from our members to obtain, retain and use their personal information in our Club membership database and Membership directory.

We need evidence that we are complying with the principles of data protection, which includes evidencing that members provided consent.
